## Dear Permittee:

The Missouri Department of Natural Resources' Water Protection Program received your application for renewal of Missouri State Operating Permit MO-0129003 on November 4, 2015.

The current application lists Liberty Baptist Church as the continuing authority. As there are numerous entities with this name or variations listed with the Missouri Secretary of State's office as a corporation in good standing with the state, please confirm which entity is the correct name for the Owner and Continuing Authority for this facility by providing the charter number.

Department's regulations require that each application for an operating permit shall identify the person, as that term is defined in Section 644.016(15), RSMo, that is the owner of, operator of, or area-wide management authority for a water contaminant source, point source, wastewater treatment facility, or sewer collection system. This person shall be designated as the continuing authority. The person designated as the continuing authority is responsible for compliance with all permit conditions.

Continuing authorities are listed in preferential order in the regulations, level one (1) through level five (5). A level three (3), four (4), or five (5) applicant may constitute a continuing authority by showing that a level one (1) or two (2) are not available; do not have jurisdiction; are forbidden by state statute or local ordinance from providing service to the person; or that it has met one of the requirements listed in 10 CSR 20-6.010(2)(C)1.–7.

The Boone County Regional Sewer District (BCRSD) and the city of Columbia jointly are the level two (2) continuing authority in Boone County. The BCRSD and city of Columbia notified the Department that both the BCRSD and city of Columbia sewer collection systems are available for connection for your facility. If the applicant wants to propose the use of a lower



preference continuing authority (Liberty Baptist Church) when the higher level authority (BCRSD or city of Columbia) is available, the applicant must submit to the Department by June 13, 2022, one (1) of the following for the Department's review:

- A waiver from the BCRSD and/or the city of Columbia;
- A written statement or a demonstration of non-response from the BCRSD and/or the city of Columbia declining the offer to accept management of the additional wastewater;
- All parts of the legal boundary of the property to be connected are beyond two thousand feet (2000') from the collection system operated by the BCRSD and/or the city of Columbia;
- The proposed connection or adoption charge by the BCRSD and/or the city of Columbia would equal or exceed what is economically feasible for the applicant, which may be in the range of one hundred twenty percent (120%) of the applicant's cost for constructing or operating a wastewater treatment system;
- The proposed service fee on the users of the system by the BCRSD and/or the city of Columbia that is above what is affordable for existing homeowners in that area;
- Terms for connection or adoption by the BCRSD and/or the city of Columbia that would require more than two (2) years to achieve full sewer service; or
- A demonstration that the terms for connection or adoption by the BCRSD and/or the city of Columbia are not viable or feasible to homeowners in the area.

When the Department receives the information from the applicant, the Department will then review the availability of the connection.

For permitted facilities where the Department agrees that the connection is available under the terms of the regulation, the permit application will be considered incomplete and the Department will deny the application. In addition, failure to submit a response by the deadline will result in the permit application being considered incomplete and the Department will deny the application.

Please be aware the Department developed a new in-house Electronic Discharge Monitoring Report (eDMR) system to replace the third-party E2 eDMR system owned and maintained by EnfoTech. The new eDMR system utilizes the Missouri Gateway for Environmental Management (MoGEM) as the main login mechanism. MoGEM utilizes the U.S. Environmental Protection Agency's (EPA) Shared Cross-Media Electronic Reporting Rule (CROMERR) Services portal for registration and identity verification. Current users of eDMR are required to register as a new user through MoGEM before their next Discharge Monitoring Report is due. Paper applications are no longer utilized.
