Notice is hereby given that the Boone County Regional Sewer District will conduct a public hearing in compliance with Chapter 250.233 of the Revised Statutes of Missouri to consider a proposed 2.56% increase to sanitary sewer rates. The proposed rates are \$27.65 base service fee and \$8.50 per 1,000 gallons of water usage fee, which will be an increase of \$1.75 per month for an average user. The new rates are proposed to be effective July 1, 2023. This rate is recommended by a User Rate Study and the Board of Trustees based upon the estimated cost to keep up with on-going operation and maintenance expenses, provide adequate debt service coverage for existing loans, and to provide capital to rehabilitate/replace infrastructure. 
