- 1. Daily discharge of wastewater into the District's collection and treatment system shall not exceed the gallon per day discharge limit specified above without issuance of a new permit under District regulations.
- 2. Any special conditions endorsed on this permit shall be observed and complied with at all times while this permit is in force and effect.
- 3. As a condition of this permit, the permittee and any successor or assign to the permittee consents to the entry of District personnel on to the property, which is the subject of this permit at reasonable times and off any District easement for the purposes of inspection of wastewater discharge and collection facilities on the property for the purpose of determining compliance with the terms and conditions of this permit.
- 4. This permit is not an effluent discharge permit and does not authorize the discharge of treated or untreated effluent off the property that is the subject of this permit. The permittee or the permittee's successor in title shall at all times be responsible for assuring that effluent is contained on the subject property and properly discharged into District waste water collection and treatment facilities.
- 5. This permit and any notice of revocation thereof is binding upon the permittee and the permittee's successors in title and shall be recorded in the public land records of Boone County, Missouri, at the permittee's expense within four (4) calendar days of issuance or revocation with proof of recording furnished to the Boone County Regional Sewer District upon demand.
- 6. This permit may be revoked by the undersigned Issuer upon notice and after hearing for the violation of any term or condition contained herein. In the event of revocation, District may disconnect collection facilities to the property, which is the subject of this permit, and/or bring any additional legal action as may be authorized by District regulations.
- 7. The permittee agrees to provide any successor in title to the subject property or persons in possession thereof with a copy of this permit.
