Jesse,

The BCRSD has reviewed your request dated May 22, 2024 requesting:

- 1. Board of Trustees consent to allow the City of Columbia to connect a sewer trunk line into BCRSD manhole 12532
- 2. Board of Trustees agree to re-assignment of a particular section of easement to the City of Columbia

Please advise your client that prior to consenting to the requested connection to the BCRSD system or agreeing to reassign the specified easement, BCRSD will be requesting that the City of Columbia:

- 1. Amend the Meadowlake agreement to add an automatic renewal provision, similar to other provisions found in agreements between the City and BCRSD;
- 2. Amend the Grindstone Watershed Cooperative Agreement to allow for future connection to the Meadow Village treatment facility by properties currently outside the boundary of the agreement; and
- 3. Amend the Grindstone Watershed Cooperative Agreement to expand the existing boundaries of the agreement to include an area containing 12-15 private lagoons as BCRSD customers in an effort to remove the private lagoons from service and regionalize the provision of sewer service in the area.

Would you please advise as to who you have been working with at the City of Columbia so that I can reach out to the appropriate person/persons to begin these discussions with the City?

We will keep you apprised of the progress of our discussions with the City, and we will notify you as soon as a decision regarding granting consent to connect to the BCRSD system and/or agreeing to re-assign the easement is made.
