

RFP FOR INFORMATION TECHNOLOGY SERVICES – ADDENUM #1

NOTICE TO ALL BIDDERS:

THE RFP DOCUMENTS REMAIN UNCHANGED AND PROPOSAL DUE DATE AND TIME REMAINS UNCHANGED. THE FOLLOWING QUESTIONS ARE BEING ANSWERED TO PROVIDE ADDITIONAL CLARITY TO THE DOCUMENT.

QUESTION #1: WOULD BCRSD ALLOW US TO PROPOSE ADDITIONAL OPTIONS FOR SERVICE THAT ARE NOT IDENTIFIED IN THE SCOPE OF WORK?

- ***ANSWER: ANY VOLUNTARY ALTERNATE PROPOSALS SHOULD BE CLEARLY SEGREGATED FROM THE BASE PROPOSAL SO THAT COSTS FOR THOSE SERVICES ARE NOT INTERMINGLED WITH THE SCOPE OF THE BASE PROJECT. BCRSD MAY ENTERTAIN THESE PROPOSALS IF IT IS SOMETHING THE SELECTED OFFEROR IS CAPABLE OF PROVIDING, BUT IT WOULD NOT FACTOR INTO THE OVERALL SELECTION CRITERIA OUTLINED IN THE PROPOSAL.***

QUESTION #2: HOW WILL BCRSD MAKE A SELECTION OF PROVIDER, AND WHAT IS THE TIMEFRAME FOR MAKING A SELECTION?

- ***ANSWER: BCRSD WILL HOLD A SELECTION COMMITTEE MEETING TO REVIEW THE PROPOSALS ON THE WEEK OF JUNE 30TH. THE COMMITTEE RESERVES THE RIGHT TO CALL AND CHECK REFERENCES, ASK QUESTIONS, ETC. BEFORE PERFORMING THE FINAL SCORING OF THE PROPOSALS. ONCE THE FINAL SCORING IS COMPLETE, WE WILL PROVIDE THAT TO ALL OFFERORS, AND MAKE RECOMMENDATION AT THE JULY BOARD MEETING TO WORK OUT A CONTRACT WITH THE SELECTED OFFEROR.***

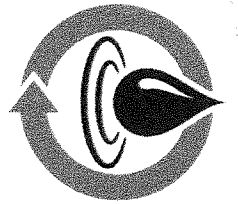

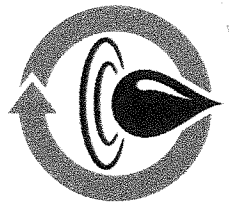
