Dear Board of Trustees,

I've done a significant amount of outreach in the past few weeks to begin engaging all of our various stakeholders with the AWMP and CIP process we are going through. Please find attached my stakeholder list and engagement log. Stakeholders highlighted in green have scheduled meetings, and the ones highlighted in blue have been engaged to provide them information, schedule phone calls, or request additional meetings or presentations. I consider this a thorough list of stakeholders, but I believe there are likely others I should add to this list, so I would encourage you to review this and provide me any possible suggestions of who I might be able to add to this list. Specific contact information would be helpful if you have it.

Additionally, in anticipation of a formal public hearing, I've went ahead and made a request to reserve their community building for the evening of September 8th, 2025. This does not commit us to this date, but their building fills up fast, and this was one of the first dates that seemed realistic to have most of the stakeholder engagement done and be ready for a public hearing. I'll be interested in your thoughts on this timeline and any other suggestions on the communication effort. I was able to give my first presentation of this at the Boone County Planning and Zoning Commission meeting on 6-12-2025, and received good questions, and I'm hopeful that those commissioners will provide feedback through our online portal. More to come!

Also, please find a document showing our communication efforts with the City of Columbia. I am working on scheduling meetings with staff to go over both documents and look for shared opportunities to work together.

BCRSD Long-Term Planning Efforts and Area Wide Management Plan

Over the past year, the Boone County Regional Sewer District (BCRSD) has been engaged in a long-term planning process that had yielded an Area-Wide Management Plan (AWMP) and Capital Improvement Plan (CIP). As a key stakeholder, we are pleased to provide an overview of these efforts to solicit your feedback and to identify areas for continued collaboration.

Drafts of the AWMP and CIP are available for review and comment on our website at www.bcrsd.com

<u>Area Wide Management Plan</u>

BCRSD worked to develop an Area-Wide Management Plan (AWMP) that updates the 2013 "*Tier 2 Plan for Private Facilities*" originally approved by the Missouri Clean Water Commission in connection with its designation as a Tier-2 Continuing Authority for Boone County jointly with the City of Columbia.

This Tier-2 designation empowers BCRSD under state regulations to encourage regionalization of wastewater collection and treatment services in Boone County, particularly in situations involving failing or inadequate private facilities permitted. BCRSD intends to submit the AWMP for Missouri Clean Water Commission approval later this year after completing its public outreach and education efforts.

Benefits of the AWMP and the Tier-2 Continuing Authority for BCSRD are summarized below:

• Water Quality Protection

- Approximately two-thirds of Boone County's water shed areas flow southwesterly through the greater Columbia area. Many wastewater facilities operate in this area. Wastewater planning in northern Boone County affects stream health in the Perche and Hinkson Creeks.
- The Bonne Femme Watershed is a highly sensitive watershed where multiple wastewater facilities are located. Regionalization efforts are important within this watershed.
- Boone County communities like Sturgeon, Centralia, Rocheport, Ashland, and Hartsburg have unique regionalization challenges due to their location in other watersheds. However, collaboration with BCRSD provides additional resources to smaller communities.
- BCRSD's designation as a Tier 2 Continuing Authority provides a powerful tool for collaboration with DNR, municipalities and private facilities to improve water quality by promoting good planning efforts.

• Affordable and Cost-Effective Sewer Service

- Costs to build and maintain public sewer systems have escalated dramatically in the past five years. Opportunities to regionalize are critical. Economies of scale are necessary to mitigate rising costs for all sewer providers.
- Partnering opportunities allow BCRSD to provide remote communities with affordable operations, maintenance, and planning help within Boone County.
- Regional Planning, Affordable Housing and Economic Development
 - With its Tier-2 Continuing Authority, BCRSD is well-equipped to facilitate efforts by cities, the county and other stakeholders to plan for future growth and economic development.
 - BCRSD has continued to cultivate strong relationships and identify opportunities for collaboration and partnerships in maximizing resources available for sewer infrastructure.
 - BCRSD provides guidance to prospective developers within the county for sewer infrastructure development and assists the private sector in smart growth.
 - Affordable sewer service is a critical component of affordable housing. Leveraging existing and proposed sewer resources efficiently helps affordability.



BCRSD – CAPITAL IMPROVEMENTS PLAN OVERVIEW

The Capital Improvements Plan (CIP) is a long-range planning document outlining a strategy for identifying, prioritizing and financing improvements to the BCRSD wastewater collection and treatment infrastructure over the next 20 years. The CIP provides planning level improvement recommendations to address changes in regulations, population growth in Boone County, and aging infrastructure. The CIP emphasizes projects that enhance environmental compliance, treatment facility upgrades and expansion, collection system improvements and operational enhancements.

• Environmental Compliance

- Currently 9 of 22 BCRSD-owned wastewater facilities are under water quality schedules of compliance with DNR. All of these require costly upgrades to meet these target deadlines.
- 6 of the 9 facilities facing a schedule of compliance are anticipated to be decommissioned and regionalized to a larger wastewater facility.
- The South Route K facility is the largest BCRSD facility with a water quality schedule of compliance. This facility could cost over twenty million dollars to upgrade. Additional options are being investigated to optimize the existing facility and help reduce the overall cost of this project.

• Treatment Facility Upgrades and Expansion

- 10 of the 22 BCRSD facilities require major maintenance projects within the next 10 years, including rehabilitation of aging tanks and mechanical equipment at various locations around Boone County.
- Capacity upgrades are anticipated at the Rocky Fork WWTF to handle growth and expansion in the area north of Columbia. This will require a multi-million-dollar investment.


• Collection System Improvements

- Improvements are needed to upgrade undersized pump stations or construct gravity sewer interceptors to eliminate pump stations.
- Sewer line upgrades are needed to relieve bottlenecks in both pressure and gravity sewer networks.
- Aging gravity sewer collection systems need continuous evaluation and rehabilitation. Refurbishment of the collection system is projected to cost over twenty-five million dollars in the next twenty years.

• Operational Enhancements

- Biosolids and wastewater treatment byproducts are expensive and labor intensive to manage. Newer and more efficient sludge management equipment is needed to reduce operational costs.
- Asset management technology, system evaluation projects, and targeted maintenance will improve preventative maintenance procedures and prolong the life of the system.

PARTNERING OPPORTUNITIES AND SHARED PRIORITIES

Identifying partnership opportunities with other sewer providers in Boone County is mutually beneficial. These partnerships can help to reduce overall costs and maximize limited resources. This helps reduce the burden on sewer ratepayers and improves water quality for shared creeks and streams. Several of these potential partnerships are outlined below:

• Sewer Discharge Point Elimination

 Both the City of Columbia and Boone County face increasing challenges for improving stream health in the Perche, Hinkson, and Bonne Femme watersheds. Projects that eliminate sewage discharge points within those watersheds by consolidating treatment plants help improve overall water quality in the watershed.

Henderson Branch Sewer Extension

- This project will extend the City of Columbia sewer to the Midway area and provide the potential to eliminate at least one private DNR facility and one BCRSD maintained facility.
 - BCRSD and City should work out cooperative agreements with each other for this extension, including any territorial agreements necessary for this extension.
 - City should agree to receive flow from Midway Truckstop.
 - BCRSD, City, and VH Properties should work out agreement to connect the Midway USA treatment plant on Van Horn Tavern Drive to Henderson Branch Sewer Extension.

• South Route K

- Both the City of Columbia and BCRSD have seen significant growth near the southwest portions of the city. Significant future growth is projected but the unavailability of cost-effective sewer infrastructure hampers growth in the area.
- The South Route K facility is located within the Bonne Femme Watershed, heightening the importance of good planning in this area.
- BCRSD and the City of Columbia should collaborate and explore opportunities to regionalize the South Route K facility. Engineering Alternatives should be evaluated and a cost-benefit analysis should be performed before construction of a new treatment facility in this area.
- Possible Areas of Study Include:
 - See if various intermingled force mains and pumpstations can be consolidated and/or eliminated.
 - Possible utilization of modified South Route K lagoons as a flow equalization basin to be pumped to the city during off-peak hours.
 - Possible utilization of the South Route K lagoons as an emergency overflow for the City's Cascades Pump station or other city sewers in the area.



- *Explore a cooperative agreement for the South Route K area that identifies city and BCRSD service areas.*
- Doing a cost-benefit analysis of a new treatment plant vs. working out a cooperative agreement with City of Columbia to pump wastewater from this area to the City of Columbia WWTP.
- Other BCRSD wastewater facilities within the 2004 Columbia Wastewater Study Area
 - There are a number of BCRSD facilities within the study area for which partnering opportunities should be evaluated, including:
 - West Region Midway Arms, Midway Crossing, Midway USA, Trails West
 - Midway Arms should be connected to Henderson Branch Sewer Extension via a cooperative agreement with the City of Columbia.
 - BCRSD should continue progress to connect the Trails West Lagoon to the Midway Crossings Treatment Plant, with a longer-term goal of regionalizing both to the City of Columbia.
 - BCRSD and City should explore if there is a way to connect Midway Crossings treatment plant to the Henderson Branch Sewer Extension.
 - North Region Kincade Crossing, Richardson Acres, Rocky Fork, Brown Station
 - BCRSD should move forward with its Route B project to regionalize and remove Richardson Acres and Brown Station Facility. BCRSD should explore connecting to city facilities or routing these facilities to Rocky Fork WWTP depending on funding availability.
 - BCRSD should upgrade or regionalize the Kincade Crossings WWTP to Rocky Fork treatment plant.
 - BCRSD should discuss with City a long-term solution of regionalizing the Rocky Fork WWTP system to the City of Columbia.
 - East Region Highfield Acres, American Outdoor Brands
 - Highfield Acres will be removed and connected to the City later in 2025. That project should continue as planned.
 - The American Outdoor Brands facility should be regionalized to the City of Columbia via the Grindstone Phase 3 sewer extension currently under construction. This should happen prior to any major capital expenditures on this facility.
 - South Region Brookfield Estates, Prairie Meadows
 - The Prairie Meadows Facility discharges to Gans Creek Watershed and BCRSD and City should study and explore if there are any technical options that would allow this facility to Pump to the City of Columbia. A Cost-Benefit Analysis should be examined for this facility to regionalize.
 - Brookfield Estates is a newer facility, but BCRSD should study long-term regionalization to the South Route K Facility and or regionalization to the City of Columbia if the South Route K facility regionalizes to the City of Columbia.



• Private DNR wastewater facilities in the 2004 Columbia Wastewater Study Area

- There are approximately 11 DNR permitted facilities within the study area that are privately maintained and in various stages of compliance. Partnering opportunities should be researched on the following facilities:
 - Carlos Acres WWTF; Cornell's Friendly Acres WWTF; Crowley Subdivision; Mathis Mobile Home Park WWTF; Midway Auto/Truck Plaza WWTF; Page Property WWTF; Phenora North WWTF; Pierpont Store WWTF; Smithview Development WWTF; Southridge Mobile Home Park WWTF; Woodstock Mobile Home Park WWTF
 - Carlos Acres is many miles northwest of the nearest BCRSD or City Facility. This would be a long-term discussion for any regionalization efforts for this facility.
 - Cornell's Friendly Acres is adjacent to both BCRSD South Route K System and City of Columbia. Options to connect this facility should be explored by BCRSD and discussed with the City.
 - Crowley's Subdivision should regionalize to the BCRSD Rocky Fork Facility.
 - Mathis Mobile Home Park and BCRSD should explore connecting this facility in conjunction with Route B improvement projects. BCRSD should discuss either connecting to Rocky Fork or possible regionalization to City of Columbia.
 - Midway Truck Stop should regionalize to City of Columbia via the Henderson Branch Sewer Extension.
 - Page Property should connect directly to the City of Columbia and close the facility.
 - Phenora North will be closed and decommissioned by BCRSD via a Neighborhood Improvement District.
 - Pierpont Store should be considered if any sewer improvement projects are considered along the Hwy 63 Corridor. The facility is no-discharge, but this should continue to be discussed.
 - The Smithview Mobile Home park should regionalize to the Rocky Fork
 WWTP
 - Southridge Mobile Home Park should ultimately regionalize either to the City of Columbia or to the BCRSD Prairie Meadows Treatment Facility.
 - The Woodstock Mobile Home park should regionalize to the City of Columbia WWTP.



NEXT STEPS

BCRSD desires to communicate with key stakeholders during the next few months and collect necessary feedback and make adjustments to the Area Wide Management Plan and Capital Improvements plan prior to holding a formal public hearing. Our goal is to have the Area Wide Management Plan approved by the Clean Water Commission later this year. Our proposed process is as follows:

• Stakeholder Meetings:

- June and July of 2025 will be dedicated to stakeholder meetings. Key stakeholders will be contacted for individual meetings where applicable. Our goals in individual stakeholder meetings are:
 - Education and Outreach. Help stakeholders understand what the AWMP is, and how it affects them.
 - Listening. Hear from stakeholders and incorporate feedback into any revisions of the Draft AWMP and CIP. Feedback from City of Columbia is important.

• Public Hearing:

- A public hearing would be conducted in August of 2025 to solicit any other feedback and direct staff to make any final changes to the AWMP and CIP.
- The AWMP and CIP would be voted on at the August 2025 Board Meeting to approve and present to the Clean Water Commission.

Working with the City of Columbia is a critical component of this, and the following course of action will aid in this accomplishment:

- City of Columbia Leadership and BCRSD Board of Trustees encouraging their staffs to work cooperatively together to identify shared priorities.
 - Each staff could identify and rate the top shared priorities and look for options to work cooperatively on those projects.
 - Identify costs and funding shortfalls and communicate with the City Council and BCRSD board of trustees on funding problems and come up with potential ideas for funding strategies.
 - City Staff could do a review of BCRSD's AWMP and CIP and ask any questions of BCRSD staff, whether informally or formally.
- Resolutions from City of Columbia and BCRSD Board of Trustees
 - We would encourage the City of Columbia to consider a resolution affirming the BCRSD AWMP and CIP process.
 - Consider directing staff to write a memo indicating they had reviewed and offered feedback to the district on the AWMP and CIP.
 - BCRSD staff should work with City staff to determine official correspondence and resolutions needed for BCRSD to affirm the progression of the Henderson Branch Sewer Extension.
