### RESOLUTION OF THE BOARD OF TRUSTEES OF THE BOONE COUNTY REGIONAL SEWER DISTRICT

Resolution authorizing the filing of an application with the Missouri Department of Natural Resources, State Revolving Fund Program for loans and/or grants under the Missouri Clean Water Law (Chapter 644, RSMo.).

WHEREAS pursuant to the terms of the Missouri Clean Water Law, Chapter 644, Revised Statutes of Missouri, the State of Missouri has authorized the making of loans and/or grants to authorized applicants to aid in the construction of specific public projects.

NOW THEREFORE, be it resolved by the Board of Trustees of the Boone County Regional Sewer District:

1. That Wendy Wiegers be and she is hereby authorized to execute and file an application on behalf of the Boone County Regional Sewer District with the State of Missouri for a loan and/or grant to aid in the construction of the closure of the Richardson Acres Lagoon and the Brown Station Recirculating Sand Filter and connection of the Richardson Acres Service Area and the Brown Station Service Area to the BCRSD's Rocky Fork wastewater collection and treatment system.

That Wendy Wiegers, Human Resources and Finance Manager is hereby authorized and directed to furnish such information as the Missouri Department of Natural Resources may reasonably request in connection with the application which is herein authorized, to sign all necessary documents on behalf of the applicant, to furnish such assurances to the Missouri Department of Natural Resources as may be required by statute or regulation, and to receive payment on behalf of the applicant.
