## RESOLUTION NO. 2026-01

### A RESOLUTION DECLARING THE INTENT OF THE BOONE COUNTY REGIONAL SEWER DISTRICT TO REIMBURSE CERTAIN CAPITAL EXPENDITURES WITH PROCEEDS OF SEWERAGE SYSTEM REVENUE BONDS OR LEASE PURCHASE OBLIGATIONS

**WHEREAS**, the Boone County Regional Sewer District (the “District”) is a public sewer district organized and existing under the constitution and laws of the State of Missouri

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE BOONE  
COUNTY REGIONAL SEWER DISTRICT, AS FOLLOWS:**

**RESOLVED**, that the Boone County Regional Sewer District (the “District”) has made or expects to make capital expenditures in connection with renovating its headquarters facility at 1314 N. 7<sup>th</sup> Street (collectively, the “Project”). The District intends to pay for or reimburse itself for such Project expenditures with (1) proceeds of a tax-exempt lease purchase transaction to be entered into by the District in a maximum principal amount not expected to exceed \$4,000,000 and/or (2) proceeds of the District’s (a) remaining unissued sewerage system revenue bonds in the maximum principal amount not expected to exceed \$3,079,501.02 previously authorized by voters of the District at the April 8, 2008, election and (b) sewerage system revenue bonds in the maximum principal amount not expected to exceed \$75,000,000 if said bonds are authorized by voters at an election anticipated to be held in the District in 2027.
